Child care programs in the State of South Carolina must adhere to strict teacher/child ratios to ensure the safety of all children. It is important that parents pick up and drop their child(ren) in a timely manner. All children must arrive prior to 9:30am and must be picked up no later than 6:00pm.					
Child tuition is due Every other Friday prior to services being rendered. All families must utilize Brightwheel for electronic tuition processing. Failure to do so will result in a weekly processing fee of \$25.00. If for any reason a credit card or check is declined or returned, there will be a \$35.00 fee assessed to the family account immediately. If there ever is a second					

occurrence, we will no longer be able to accept payments via credit card or check. Money orders will be required for tuition payments.

<ul> <li>Parents will be held responsible for the following:</li> <li>Personal supplies (Diapers, wipes, clothes, blanket, etc.)</li> <li>Personal property damaged that has been brought into the center</li> <li>Personal items lost or stolen</li> </ul>
—— If your child(ren) is going to be out due to illness, appointments, etc., please contact the school to let us know. If your child(ren) is absent, you are still required to pay that week's fuition in full.
Eamilies are granted one (1) free week per calendar year of tuition for vacation so long as a thirty (30) day written notice is provided and days are taken consecutively.
Families are still expected to pay their tuition during holidays and/or early release dates
Any child receiving Subsidies must be enrolled full-time, this means you must attend 25-60 hours per week to maintain your placement in the center and benefits with DHS. Per the State of South Carolina, families are granted ten (30) absent days annually for vacation, sick days, etc. If at any time a family exceeds their allotted days, they will be responsible to private pay for that week's tuition.
I understand all deposits are non-refundable at any time for any reason.
— A child is not considered fully enrolled until the deposit and first two weeks of tuition has been received.
I fully understand failure to pay tuition every other Friday will result in a \$25 per day late fee assessed on Monday and thereafter not to exceed \$100.00. Any account that reaches this level will have services suspended until payment is received in full.
orders will be required for fulfion payments.

Each child that enrolls at Our Kia's CDC will be granted a thirty (30) day probationary period starting from the first day in attendance. This time is to allow the staff and your child to adjust to the new setting. During this time if the parent or center wish to terminate, a two-week written

notice must be provided.

This contract may be terminated by the parent at any time for any reason with a written two-week notice. Failure to do so will result in the parent being financially responsible for their child's last two weeks of tuition.
In the event of an emergency, I agree that Our Kid's CDC may administer first aide or obtain medical treatment for my child. I agree to pay all expenses incurred by the physicians, emergency room, or the emergency squad. Our Kid's CDC will not be held liable for any medical expenses for my child.
There are <b>NO REIMBURSEMENTS</b> , financial or otherwise, for days or hours the client's child/children may have missed due to illness or other emergencies.
Note: Our Kid's Child Development Center may terminate this contract immediately for failure to adhere to this contract at any time.
Financial Hardship:
— We understand that financial hardship issues may arise from time to time, however, you are still required to pay tuition and/or copays in full. Under some circumstances a payment arrangement may be made under the discretion of the center director. Any approved arrangement shall not exceed three (3) business days.
Permission to Photograph and/or Email:
